## 5. Self-help skills and independence

7. The physical environment (accessibility, safety and positive learning environment).

<ul style="list-style-type: none"> <li>• All areas of the school are accessible to everybody.</li> <li>• Wheelchair access is available to all classes.</li> <li>• Pupils feel safe in an environment where bullying is absolutely minimal and dealt with effectively.</li> <li>• There is a designated 'Designated Safeguarding Officer' (and deputy) and a named Child in Care teacher.</li> <li>• Teachers focus on rewarding good behaviour to promote a positive learning environment.</li> <li>• Staff and visitors wear identification lanyards.</li> <li>• Staff and visitors are required to sign in and out.</li> <li>• No mobile phones are allowed in the school</li> </ul>	<ul style="list-style-type: none"> <li>• Access to specialist equipment resources where appropriate.</li> <li>• Quiet areas are available.</li> <li>• Changing facilities available</li> </ul>	<ul style="list-style-type: none"> <li>• Designated teaching areas are available.</li> <li>• Two disabled parking bays.</li> <li>• Disabled toilet</li> <li>• Lift</li> </ul>

## 8. Transition from year to year and setting to setting

It is well planned &amp; takes place regularly &amp; progressively.</li> <li>• The EYFS teachers identify pupils who may need extra support through transition sessions and visits feeder nurseries prior to entry.</li> <li>• There are very strong links with the receiving secondary school, Richard Lander. Pastoral leads identify pupils who may need extra support.</li> <li>• Taster sessions happen throughout the year and in a variety of curriculum areas.</li> <li>• Two days of visits to receiving school. Following visit from Transition team including Year 7 pupil mentors.</li> <li>• Extra visiting days arranged for pupils who need them.</li> <li>• 'Move up' morning across the school allows all pupils to work with their new teacher.</li> </ul>	<ul style="list-style-type: none"> <li>• SENCo and class teachers liaise with pre-school and secondary school to ensure all information is shared before transition.</li> <li>• Every child's individual needs are discussed between teachers prior to transition, as are IEPs and Communication Passports.</li> </ul>	<ul style="list-style-type: none"> <li>• Where necessary, individualised transition programmes are put in place.</li> <li>• School SENCo visits in Summer Term</li> <li>• Photo books prepared for preschool settings and families to familiarise pupils with changes</li> </ul>

9. Pupil progress:

Academic progress is tracked using the 'Gradebooks' online assessment programme. This is monitored termly. In addition to this, children on the Special Educational Needs register of need have Individual Education Plans that outline short term targets linked to their area of need. These are reviewed termly and progress shared with parents and pupils. For pupils with Education Health Care Plans, annual reviews take place in addition to the termly IEP reviews where outcomes and provision are reviewed with pupil and parents and changes made as necessary.

10. How we know how good our SEN provision is:

We evaluate the effectiveness of provision for pupils with SEN through the monitoring, assessment and review processes outlined above. We liaise closely with parents, pupils and outside agencies throughout the academic year to ensure provision is meeting the needs of the child and family and they are making progress as a result.
